Commissioner Reports:

- A. Letter to Governor Evers, Senator Janet Bewley and Representative Beth Meyers regarding proposed gas tax.
- B. Roof – C&S Design. Received 3 drawings on how to fix and went with the cheapest. C&S Design has to get state approval.
- C. CTH F Bridge – deck replacement.
- D. CTH A – Borings complete. The road only had 3.5" blacktop on it. Commissioner would like to do 9 miles of paving to complete CTH A this year and not do a project in 2020. He will have to go to the full board for approval.
- E. CTH M – Commissioner would like to do the FLAP & STP in 2021 from CTH D to Cable. He thinks there will be a better price to do both at the same time. Estimating will cost the county about \$1,450,000.
- F. CTH E – Schedule for 2022 – Slop work 5.8 miles from 63 to county line.

Committee Input:

Crandall stopped at the garage in Cable and noted that it needs some major maintenance.

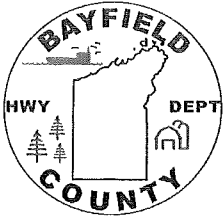
The meeting adjourned at 5:55 P.M.
