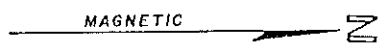
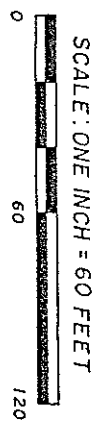

*Survey Map 1 of 2*

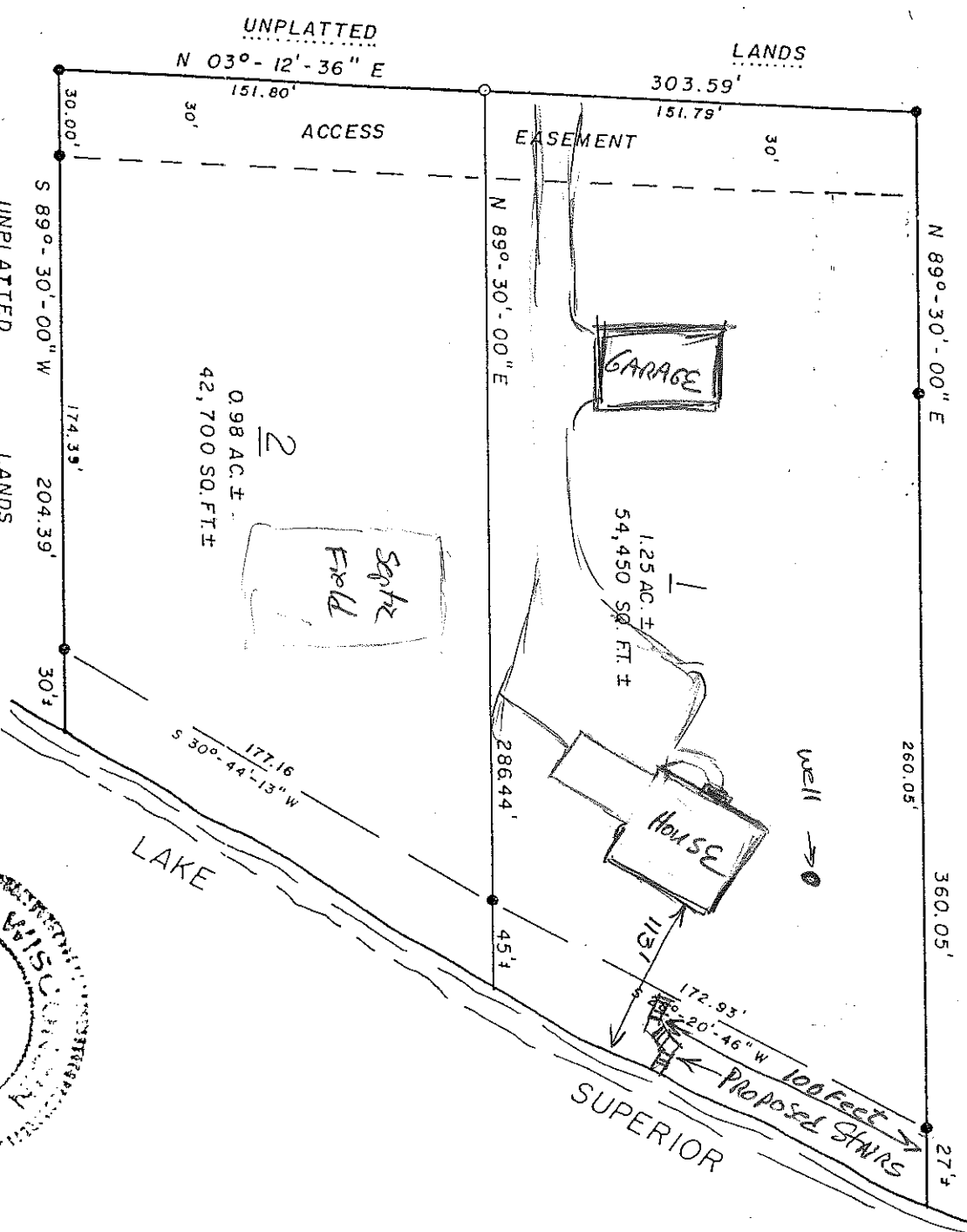

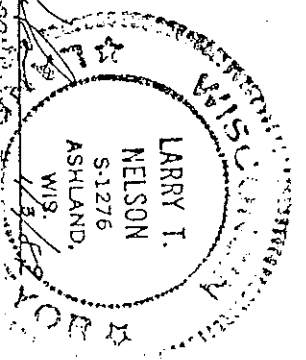
