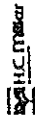

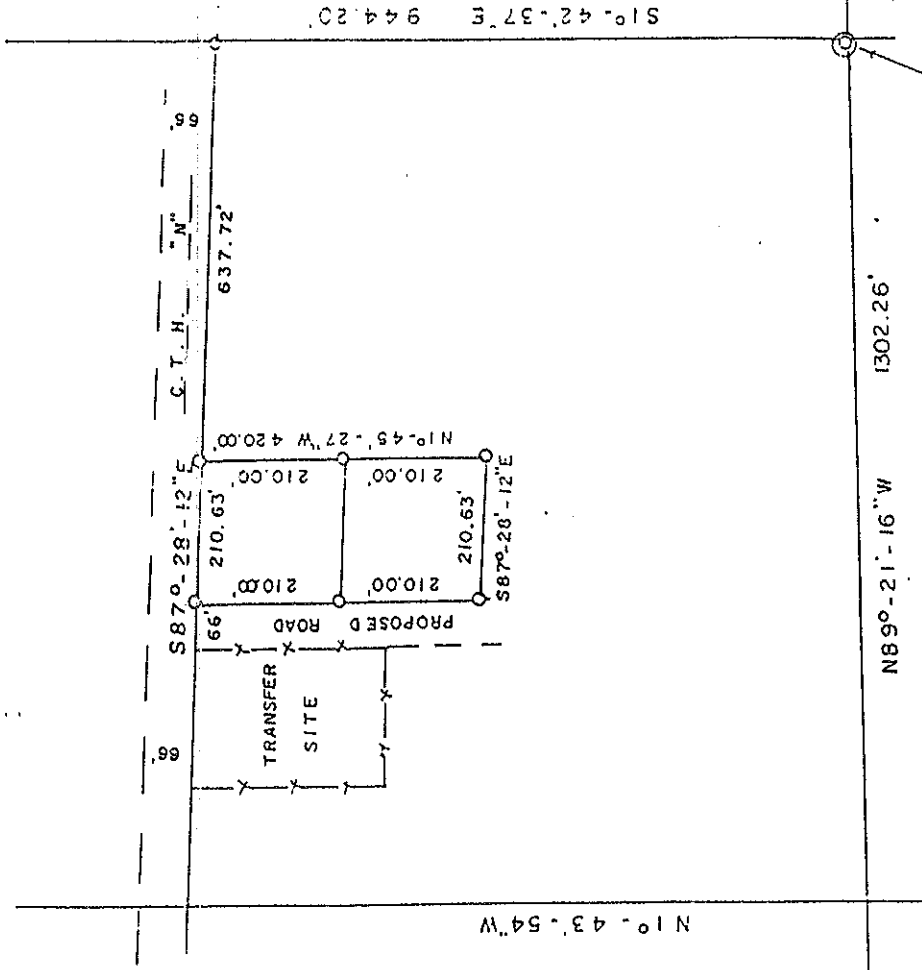

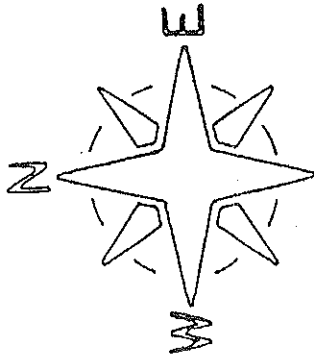
BARNES INDUSTRIAL PARK LANDS
