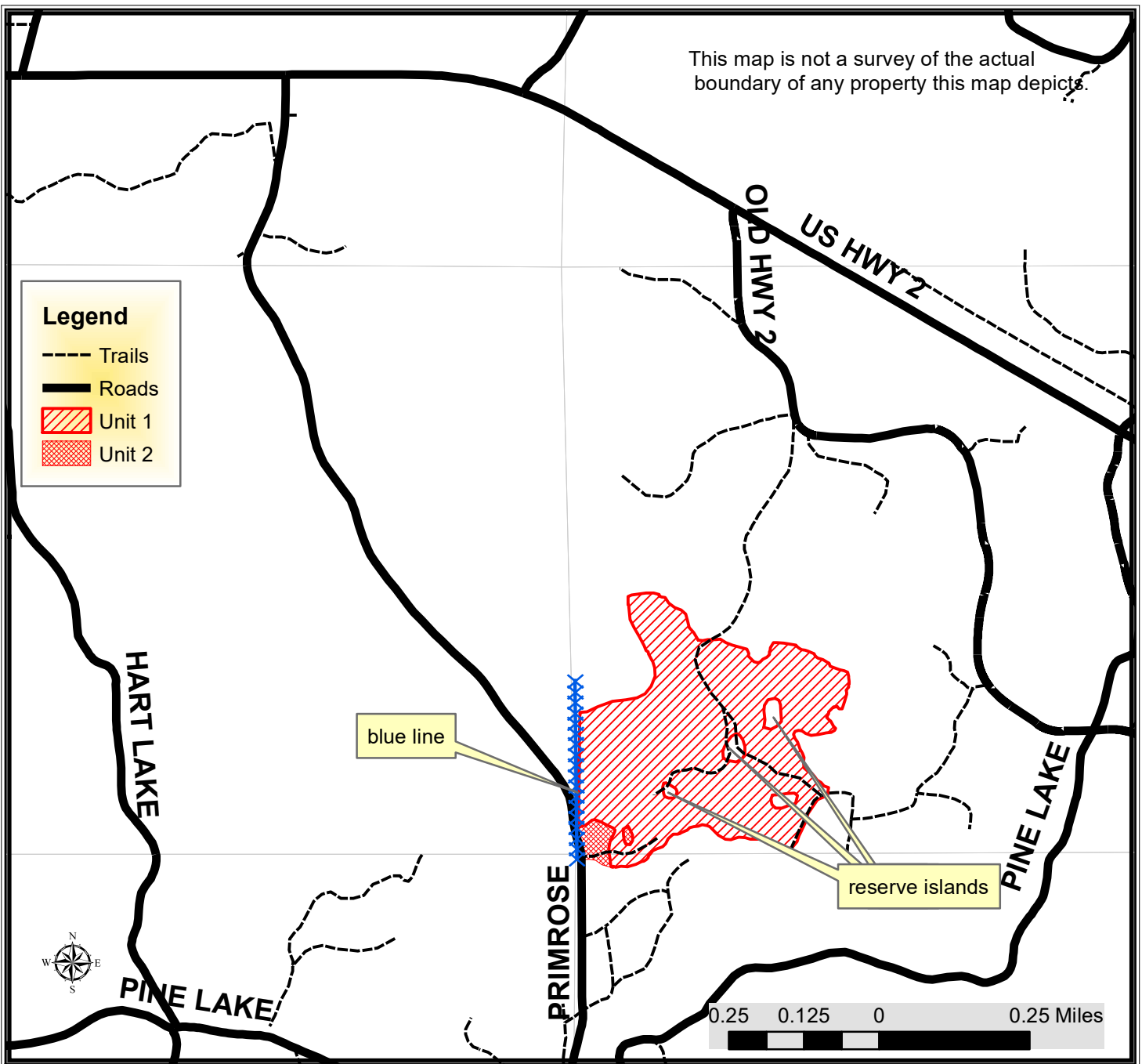

TRACT 23-21 – HARVEST REQUIREMENTS

The following terms and conditions supplement those provided in the Bayfield County Timber Sale Contract.

A. PRESCRIPTION:

- Unit 1: Harvest is an aspen coppice harvest with an estimated residual basal area of 42 ft².
- Unit 2: Harvest is a red pine thinning with an estimated residual basal area of 127 ft².

B. HARVEST REQUIREMENTS:

- Unit 1: Harvest all hardwood 4" and greater. Do not harvest hardwood or softwood painted in purple. Harvest all red pine not painted purple. Leave all white pine, fir, spruce, hemlock, and purple painted red pine. Sever all hardwood 2" and greater, except leave all oak 4" and less.
- Unit 2: Harvest all orange painted trees and all merchantable hardwood.

C. OPERATIONAL REQUIREMENTS AND SEASONAL RESTRICTIONS:

- Sale boundaries are marked out in red paint, blue paint or the adjacent timber is less than 10 yrs old.
- No seasonal restrictions.
- If harvest will utilize the whole tree, 1 in 10 tops must be left scattered throughout the sale.

D. ACCESS AND ROADS:

- This contract requires County authorization for all road/landing construction and places a number of other requirements on road construction and closure.

E. OTHER:

- Blue paint line denotes private property. No equipment or trees may cross blue painted line.
- Utilization specification is to a 4" top. However, if the County determines that pulpwood markets continue to be very poor at the time of harvest the County will sign a contract amendment with the purchaser changing the utilization specification to a 5" top for selected species. When determining condition of market, the County will pay particular attention to the amount of wood being purchased by the mills in Wisconsin Rapids and any other significant shifts in wood demand.
- To comply with Best Management Practices for Invasive Species: Prior to moving equipment onto or off the sale area, scrape or brush soil and debris from exterior surfaces to the extent practical.
