### BAYFIELD COUNTY LOCAL GOVERNMENT SCHOLARSHIP, 2019

- WHAT:** Local Government Scholarship Program, 2019
- FOR:** High School Seniors
- ELIGIBILITY:** Must be a resident of Bayfield County in their senior year of High School
- AMOUNT:** One \$1000 SCHOLARSHIP

**GOAL:** Encourage high school seniors to learn about and participate in local government through meeting attendance and essay writing.

#### REQUIREMENTS:

- Between December 1, 2018 and April 22, 2019 applicant will attend a municipal (City, Town, Village, Tribal) meeting and one county board meeting.
- Applicant will speak briefly during public comment informing the board of their intent to apply for this scholarship, including: their name, school, any interest they may have in local government and their reason for applying for the scholarship.
- On or before April 22, 2019, the applicant will submit a one-page essay on “Why I Would Consider Running for Public Office”.

**JUDGES:** The Bayfield County Board will make an award at the April Bayfield County Board Meeting or as soon thereafter as feasible.

**AWARD:** The scholarship announcement will be distributed at the school or group’s Awards Ceremony by a Bayfield County Board Member or designee. A check will be written to the school.
